**What does the fund invest in?**

This fund's objective is to preserve the value of your investment by investing primarily in mutual funds that invest in lower risk asset classes like cash or cash equivalents and fixed income securities with only limited exposure to mutual funds invested in equity securities. The fund may also invest directly in fixed income securities and cash or cash equivalents.

The charts below provide you with a snapshot of the fund's investments on May 2, 2012. The fund's investments will change.

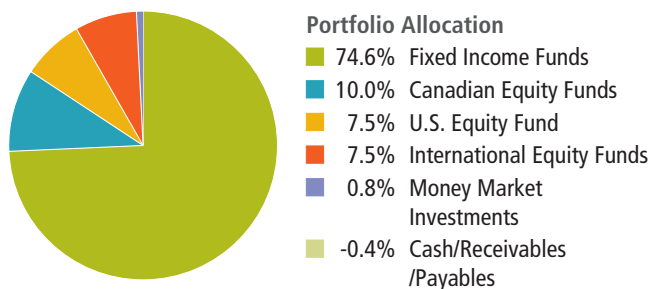

**How has the fund performed?**

This section tells you how this series of the fund has performed since inception. Returns are after expenses have been deducted. These expenses reduce the series' returns.

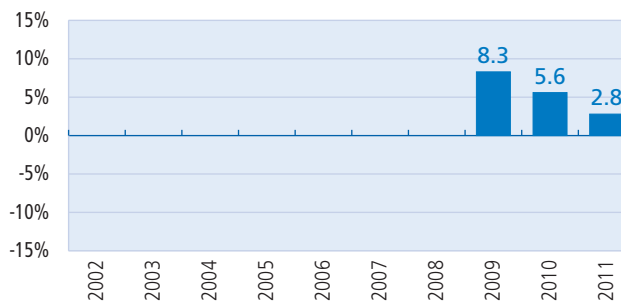
It's important to note that this doesn't tell you how the series will perform in the future. Also, your actual after-tax return will depend on your personal tax situation.

**Average return**

As at April 30, 2012, a person who invested \$1,000 in this series of the fund since its inception now has \$1,222. This works out to an annual compound return of 5.9%.

**Year-by-year returns**

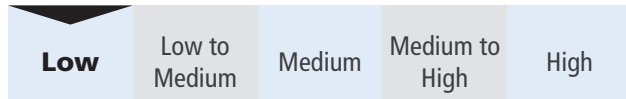
This chart shows how the series has performed in each of the past 3 completed calendar years. The series dropped in value in 0 of the 3 years.



### How risky is it?

When you invest in a fund, the value of your investment can go down as well as up. BMO Investments Inc. has rated this fund's risk as Low.

### Are there any guarantees?

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

### Who is this fund for?

#### Consider this fund if:

- you want the flexibility to switch to another class of BMO Global Tax Advantage Funds Inc. without realizing capital gains
- you want a conservative investment with the potential for some capital appreciation
- you are comfortable with low investment risk (i.e. you are willing to accept some fluctuations in the market value of your investment over the short term).

Series T8 shares are suitable for investors holding investments outside a registered plan and wishing to receive monthly distributions.

**Before you invest in any fund, you should consider how it would work with your other investments and your tolerance for risk.**

### A word about tax

Depending on the tax rules and tax rates that apply to you and the fund, you may have to pay tax on your portion of the fund's earnings and gains, whether paid out to you in cash or reinvested in the fund. Also, you may have to pay tax on any gain you realize when you redeem or sell your investment in the fund. However, if you hold your investment in a registered account such as a Registered Retirement Savings Plan or a Tax-Free Savings Account, generally you will not have to pay tax on earnings or gains that are held in the registered account.

### How much does it cost?

The following section describes the fees and expenses you could pay to buy, own and sell Series T8 shares of the fund.

The fund has other series of shares. The fees and expenses are different for each series. You should ask about other series of shares that may be suitable for you.

#### 1. Sales charges

You have to choose a sales charge option when you buy this series of the fund. You should ask about the pros and cons of each option.

## 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of this series of the fund.

As of September 30, 2011, the Series T8 expenses of the fund were 2.38% of its value. This equals \$24 for every \$1,000 invested.

### Trailing commission

BMO Investments Inc. pays your dealer (including your discount broker) a trailing commission for as long as you own the fund. It is for the services and advice about the fund your dealer provides to you. Your dealer may pay part of the trailing commission to your advisor.

The trailing commission is paid out of the management fee. The rate depends on the sales charge option you choose:

**Sales Charge Trailing Commission** - up to 1.00% of the value of your investment each year. This equals up to \$10 each year for every \$1,000 invested.

**DSC Trailing Commission** - up to 0.50% of the value of your investment each year. This equals up to \$5 each year for every \$1,000 invested. If you purchased your securities under the DSC sales charge option and the redemption fee schedule applicable to those securities is complete, the trailing commission will increase to the rate applicable to securities purchased under the Sales Charge option.

**Low Load Trailing Commission** - up to 1.00% of the value of your investment each year. This equals up to \$10 each year for every \$1,000 invested.

## 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch shares of the fund.

Fee	What you pay
<b>Short-term trading fee</b>	Up to 2% of the amount that you redeem or switch if you buy or switch and then redeem or switch shares of the fund within 30 days of purchasing or switching them. This penalty will be paid directly to the fund.
<b>Switch fee</b>	You and your dealer can negotiate this fee. Currently the fee is up to 2% of the amount you switch.

### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units or shares within two business days after you receive a simplified prospectus, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
