What does the fund invest in?

The fund seeks to replicate, to the extent possible, the performance of the FTSE TMX Canada UniverseXM Bond Index™ (the "Index"), net of expenses. The investment strategy of the fund is to invest in and hold ETFs or the constituent securities of the Index in the same proportion as they are reflected in the Index or a sampling methodology may be used in selecting investments for the fund. The Index is designed to be a broad measure of the Canadian investment-grade fixed income market consisting of federal, provincial and corporate bonds. The Index consists of semi-annual pay fixed rate bonds issued domestically in Canada and denominated in Canadian dollars, with an effective term to maturity of greater than one year and a credit rating of BBB or higher. Each security in the Index is weighted by its relative market capitalization.

The charts below provide you with a snapshot of the fund's investments on January 6, 2017. The fund's investments will change.

How has the fund performed?

This section tells you how the fund has performed over the past 6 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

It's important to note that this doesn't tell you how the fund will perform in the future as past performance may not be repeated. Also, your actual after-tax return will depend on your personal tax situation.

Average return

As at December 31, 2016, a person who invested \$1,000 in the fund 6 years ago now has \$1,331. This works out to an annual compound return of 4.2%.

Year-by-year returns

This chart shows how the fund has performed in each of the past 6 completed calendar years. The fund dropped in value in 1 of the 6 years.



How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.



Risk rating

BMO Asset Management Inc. has rated the volatility of this fund as **Low**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

How much does it cost?

The following section describes the fees and expenses you could pay to buy, own and sell this fund.

1. Sales charges

You may pay commission and brokerage fees to your dealer when you purchase and sell this fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of June 30, 2016, the expenses of this fund were 0.22% of its value. This equals \$2.20 for every \$1,000 invested.

Annual rate (as a % of the fund's value)

Management expense ratio (MER)

This is the total of the fund's management fee and operating expenses. BMO Asset Management Inc. waived some of this fund's expenses. If they had not done so, the MER would have been higher.
